President W. E. Burks reconvened the board meeting at 7:43 p.m. with Walter Walker now in attendance and seated the new board members. Incumbent members were President Burks, Clerk Linda Tucker, Trustees Betty West, Lyle Meador and new Trustee Patrick Tangney.
